



About Jinhong Gas

Development History

In 2005, the group constructed its first dry ice production line, thereby expanding the application areas of carbon dioxide. In 2009, it invested in the construction of a carbon dioxide recovery project with an annual production capacity of 100,000 tons. Also in 2009, it completed the shareholding reform, which led to an enhancement of its corporate governance structure. During this phase, the group continuously diversified its product offerings and embarked on a business model emphasizing the circular economy and exhaust gas recycling.

The group introduced the "Vertical & Horizontal Development" strategy. In terms of vertical development, it focused on independently developing and producing various high-barrier specialty gas products, expanding the production capacity of ultra-pure ammonia multiple times, and establishing new projects such as high-purity nitrous oxide and hydrogen to accelerate the industrialization of electronic specialty gases. Regarding horizontal layout, it expanded its operations across regions, deepening its roots in the Yangtze River Delta market while planning to expand nationwide, establishing retail networks in the Pearl River Delta, Beijing-Tianjin, Sichuan-Chongqing, and other regions.

The Second Five-Year Plan 2005~2009

Expanded the gas category and enhanced the brand influence.

The Fourth Five-Year Plan 2015~2019

Vertical and Horizontal layout to build the first national brand in the gas industry.

The First Five-Year Plan 1999~2004

Based in Suzhou, integrated resources and expanded the market.

In 1999, the group was established based on the former Suzhou Liquid Oxygen Manufacturing Plant. During this phase, the main products were bulk gases such as oxygen, nitrogen, argon, and acetylene. It established small air separation production units in Suzhou and acquired some gas production assets in Suzhou from L'Air Liquide. By continuously expanding its market presence, it had gradually established a sales and service network.

The Third Five-Year Plan 2010~2014

Breakthrough in high-end special gases and upgraded corporate governance.

In 2010, the group officially launched the production and operation of 7N electronic-grade ultra-pure ammonia. Following this, in 2012, it invested in the construction of a natural gas-to-hydrogen project. In 2013, the testing center had been accredited as a CNAS-approved laboratory, significantly enhancing its quality control capabilities. During this phase, the group continuously enriched its product range and significantly strengthened its product quality, detection technology, research and development capabilities, and service capabilities. With the listing of the group on the New Third Board in 2014, both brand awareness and corporate image were elevated.



Organizational Structure





Analysis of Substantive Issues

Jinhong Gas analyses its own sustainable development challenges based on the disclosure guidelines of domestic and international social responsibility/sustainable development/ESG reports, the indicators of concern to domestic and international rating agencies, and the tracking analysis of relevant policies in the industry, establishes a mechanism for the identification of material topics, and determines the annual material topics every year through the analyses and researches of internal and external related parties.

Jinhong Gas identified and evaluated the importance of ESG material topics, categorized the key ESG issues. Using the importance level for both the group and stakeholders, it created a substantive issue matrix to outline the significant ESG topics.



Topic

Green Mission for the Gas Industry

Gas is crucial to the industry, playing a vital role in the national economy and various fields. As a key support for modern industry, the gas sector is essential for achieving sustainable development. The industry's commitment to its green mission is not only a demonstration of corporate social responsibility, but also critical to promoting sustainable development.

Jinhong Gas aims to be a pioneer in establishing a sustainable factory and become a leading advocate for environmental responsibility in the industry. Through continuous innovation and optimization of production processes, Jinhong Gas strives to improve resource utilization, reduces energy consumption, and enhances energy efficiency. The ultimate goal is to achieve a low-carbon and green production process, setting an example for the industry in sustainable development. In 2023, the National Ministry of Industry and Information Technology announced the 2022 Green Manufacturing List with Jinhong Gas being honored with the title of "National Green Factory".

In order to achieve the goal of peaking carbon emissions and subsequent carbon neutrality, Jinhong Gas is actively promoting the development of a green circular economy and implementing a nationwide plan. The group has established several tail gas recovery projects on site to recover gases such as hydrogen, carbon dioxide, and nitrous oxide. By fully utilising these resources and utilising carbon dioxide and other tail gases in various fields, it has demonstrated a circular economy, reduced overall carbon emissions, and effectively promoted China's progress towards carbon neutrality. During the reporting period, Jiaxing Jinhong Carbon Capture Project entered trial production, and the Huainan Jinhong Carbon Capture and Comprehensive Utilisation Project was officially capped. The Carbon Capture and Utilisation Project can effectively promote the commercialisation and utilisation of carbon capture technology. It can also promote the establishment of an improved carbon asset trading system, provide a more friendly development space for the popularisation and application of CCUS in China, and provide a strong technological guarantee for the realisation of the goals of peaking carbon emissions and subsequent carbon neutrality.

As a group committed to driving sustainable development, Jinhong Gas aims to enhance green manufacturing practices by incorporating hydrogen energy. Hydrogen energy is a clean, carbon-free secondary energy source with widespread availability and diverse applications. It is pivotal in achieving significant decarbonization and catalyzing the transition to sustainable energy sources. Jinhong Gas is capitalizing on industry development opportunities by establishing a presence in the hydrogen energy market. It has created a comprehensive network integrating hydrogen production, storage, transportation, and refuelling.

As of the end of the reporting period, Jinhong Gas has planned five hydrogen production plants in Suzhou, Chongqing, Zhangjiagang, Meishan, and Zhuzhou. The group's logistics ensures the quality, quantity, and supply of hydrogen storage and transportation. It supplies hydrogen to refuelling stations in Jiangsu, Zhejiang, Shanghai, Sichuan, and Chongqing and provides hydrogen for hydrogen fuel cell vehicle demonstration projects, including fixed and skid-mounted refuelling stations for oil-hydrogen joint stations and "Gas-Hydrogen-Electricity Service" integrated refuelling stations, imultaneously exploring applications of hydrogen electric bicycles, forklift trucks and drones.

Looking ahead, Jinhong Gas will stay true to its founding mission and continuing to broaden its green mission both vertically and horizontally. The group will collaborate with the industry to establish a low-carbon ecosystem and contribute to the achievement of carbon neutrality. Jinhong Gas is committed to advancing the green mission of the gas industry and making significant contributions to building a beautiful China and promoting sustainable development.





Board of Directors

The Board of Directors is responsible to the Shareholders' General Meeting and serves as the decision-making body of Jinhong Gas. 


▲ Photovoltaic Power Station Successfully Connected to the Grid

The project, invested and constructed by Huainan Jinhong Carbon Dioxide Co., Ltd., won the second prize in the Huainan competition of the 12th China Innovation and Entrepreneurship Competition in Anhui Province in 2023.


The carbon capture and comprehensive utilization project can effectively promote the commercial utilization of CCUS (Carbon Capture, Utilization and Storage), facilitate the establishment of a sound carbon asset trading system, thereby providing a more favorable development space for the domestic promotion and application of CCUS, and providing strong technical support for achieving the "Carbon Peaking and Carbon Neutrality" goals.

In June 2023, Jiaxing Jinhong's Carbon Capture Construction Project commenced its trial production. The project, invested and constructed by Jinhong Gas (Jiaxing) Co., Ltd., has been selected as the third batch of pollution reduction and carbon emission reduction pilot projects and the second batch of benchmark projects in Zhejiang Province.

By utilizing upstream exhaust gas recovery and adopting advanced purification technology, the project aims to reduce emissions, minimize environmental impact, and achieve the reuse of carbon dioxide, thereby enhancing resource utilization efficiency.



Coping with Extreme Weather

Climate change is full of uncertainty and complexity, and the extreme weather it triggers, such as heavy rainfall and flooding, low temperatures and freezing temperatures, may damage factories, equipment and office buildings, resulting in the loss of Jinhong Gas's assets; at the same time, it may also indirectly impede Jinhong Gas's stable production due to the effects of damage to equipment, the inability of employees to perform their normal work, and the disruption of transport.

Routine Precautionary

- Arrange daily reminders of meteorological conditions.
- Regular inspection and maintenance of production facilities and equipment.
- Structural reinforcement of important production facilities and buildings to enhance their ability to resist wind, rain and earthquakes.
- Equip backup generators or other reliable energy supply equipment to cope with possible power outages.
- Regularly inspect and clean the drainage system to ensure that it is unobstructed to prevent waterlogging and flooding.
- Establish an emergency liaison mechanism.
- Arrange inspections to promptly notify abnormal situations and remove potential safety hazards.

Emergency Response

- Set up an emergency command team to organise and coordinate the response work.
- Formulate an emergency plan and clarify the duties of each department and personnel.
- Reserve emergency supplies in advance, such as sandbags, tarpaulins, standby generators, etc.
- In case of extreme weather, stop dangerous operations in time to ensure personnel safety.
- Organise evacuation of staff to safe areas if necessary.
- Clean up snow and water in time and repair damaged facilities.
- Assess damage and resume production.
- Summarise and improve preventive measures.

Jinhong Gas regularly commissions external professional organisations to carry out exhaust gas testing to ensure all air emissions meet the requirements of the *Integrated emission standard of air pollutants* (GB16297-1996) and the *Emission standards for odor pollutants* (GB14554-1993).

Noise Regulation

Noise generated in the production process mainly comes from the production line and other equipment, for this reason, Jinhong Gas takes noise control as an important part of the production process. In the selection of equipment, priority is given to the selection of low-noise equipment, and at the same time, vibration damping measures are strengthened and mufflers are installed to reduce the noise; at the same time, Jinhong Gas has installed mufflers in the noise sources of each process, constructed acoustic barriers in part of the factory boundaries, and carried out acoustic isolation and acoustic absorption wrapping treatment for the pipelines with a large noise value.

Waste Handling

Jinhong Gas strictly adheres to relevant national and local regulations and standards, such as the Standard for pollution control on the non-hazardous industrial solid waste storage and landfill and the Standard for pollution control on hazardous waste storage. It classifies and collects waste according to different types. For hazardous waste, Jinhong Gas establishes dedicated storage facilities and disposes of them in accordance with relevant regulations. For general industrial waste, regular cleanup and disposal are conducted. At the same time, regular supervision and inspections are carried out to ensure the effective implementation of waste management measures.






Employee Structure


