Headquartered in Chongqing, it extends its influence nationwide. It specializes in environmental protection services, including atmospheric and water pollution treatment, solid (hazardous) waste treatment and disposal, mine and soil remediation, as well as energy-related services such as new energy and comprehensive smart energy. The Company holds many qualifications in terms of environmental protection, such as air pollution prevention, water treatment, and solid waste treatment. Additionally, it possesses qualifications related to new energy construction, such as power design and construction. Simultaneously, the Company has been granted major project awards at the national and provincial levels for consecutive years. This attests to its robust business undertaking capabilities and leading competitive position within the industry. The projects are located all over **31 provinces**, autonomous regions, and municipalities directly under the central government, and are also expanded to 10 overseas countries, including 8 countries along the "Belt and Road Initiative" . The Company's annual revenue amounts to RMB 4.7 billion, while its total assets approximate RMB 10 hillion

我们聚焦"双碳"目标,以技术创新为引擎,突破关 键技术瓶颈,为CCUS产业化落地奠定基础,支持 上海长兴岛燃煤燃机CCUS项目连续稳定运行,累 计减排二氧化碳超15万吨。我们成功实现二氧化碳 加氢制甲醇工艺"零的突破",每吨甲醇可消纳1.4吨 二氧化碳,为二氧化碳资源化利用开辟新路径。我 们在光伏组件回收和风机叶片回收等技术领域取得 积极突破,已建成具有领先优势的技术示范线。我 们持续深耕电力环保、工业气水固综合治理等业务, 项目遍布全国31个省、自治区、直辖市,为各地的 蓝天、碧水、净土保卫战注入强劲动力,以科技之力 守护"美丽中国"。 2024 is a crucial year for Yuanda Environmental Protection. We have achieved positive breakthroughs in the technical aspects of recycling of PV modules and fan blades. Moreover, we have successfully established a leading-edge technology demonstration line. We have been deeply engaged in the services such as environmental protection of power, and comprehensive management of industrial gas, water, and solid waste. Projects are distributed across all 31 provinces, autonomous regions, and municipalities directly under the central government. Upon the special administration of violation of the spirit of eight-point decision of the CPC, the political inspection of party organizations of **2** affiliates has been completed. The strict discipline and precise style are becoming stronger.

By optimizing the mechanisms of "comprehensive supervision" and "three-linkage" in discipline, inspection and assessment, taking serious measures for the special rectification of bad practices and "micro corruption" around the people, and conducting education of clean politics for "leaders" and young officials, the strict keynote and a clean and upright political environment are gradually taking shape.

The Catalyst Company's leading body has organized all party members to study the Regulations for a total of 13 times, with 151 participants. The Company has held 1 warning education meeting. Secretaries and members of party organizations at all levels have given party lectures on discipline for **7 times**. Warning education has been conducted in the integrity education base for 4 times, with 58 participants group by group.

Since the Company established a leading group and a special work team, the Company has studied and prepared work plans, defined 22 concrete actions, and planned systematic education of the party discipline for the Company. Party organizations at all levels of the Company have started their work through various forms, such as party committee meetings. They have held 49 related meetings, and established **8** special organizations, to complete the work deployment from top to bottom.

The Company has held 9 special study lessons, with 239 participants. The Secretary of the Party Organization took the lead in studying the Regulations on Disciplinary Measures of the Communist Party of China, and members of the leading body exchanged experience in business. A director may be re-elected upon expiration of his term of office; the term of re-election of an independent director shall not exceed 6 years. Candidates for independent directors of the Company are nominated by the Board of Directors; candidates for directors other than independent directors are nominated by the Board of Directors or by shareholders holding more than 3% of the total number of voting shares of the Company individually or in combination. The list of candidates for directors is submitted to the shareholders' meeting for resolution by way of proposal.

Leaders at all levels insist on taking the lead in identifying hidden dangers. Members of the Company's Headquarters and tertiary units have conducted a total of **458** safety inspections, discovered and controlled 2,075 hidden hazards in work safety. The numbers of inspections and hidden dangers discovered have increased by **20%** and **39%** respectively compared to the same period, and the leaders have played a good exemplary role;

Based on the principle of classifying zones to leading groups, assigning projects to management personnel and allocating management blocks to primary-level personnel, a "zone responsibility" + "grid management" mechanism is implemented to clarify the management ranges and work standards at all levels, and construct a preliminary safety supervision network at all levels and across all departments. 针对火灾、高处坠落、触电、防洪防汛防台等生 产安全及自然灾害事故风险,公司组织开展应 急演练108次,演练方式包括实战演练、桌面 演练、双盲应急演练,参演人数共计1462人。 In 2024, the Company comprehensively inspected its work safety status and found no major risks or hidden dangers. The Company sorted out relevant issues and proposed corrective measures, for example conduct self-examination and rectification by drawing inferences about other cases from one instance, strengthen standardized work safety management, and standardize the management of construction schemes.

In the preparation stage of flood and typhoon prevention, the Company established organizations for flood and typhoon prevention at all levels and clarified emergency management responsibilities; it organized primary-level units to focus on cleaning and maintaining non-fixed facilities and rainwater drainage systems, and prepare emergency materials for flood and typhoon prevention.

In response to work safety and natural disaster risks such as fire, falling from height, electric shock, and flood and typhoon prevention, the Company organized **108** emergency drills, including practical drills, desktop drills and double-blind emergency drills, with a total of **1,462 participants**.

The Company strengthens the treatment of wastewater pollution, strictly implements the requirements of "rainwater and sewage diversion and clean water and sewage diversion", enhances the upgrading and renovation of industrial and domestic wastewater treatment facilities and realizes classified treatment, graded utilization and reasonable reuse of wastewater.

The Catalyst Company adopts zero-wastewater discharge technology. The production wastewater from primary catalysts meets tertiary standards. The water produced by primary and secondary reverse osmosis is reused in production, while concentrated water enters the evaporation system for evaporation and reuse. The salt after evaporation is disposed of by third-party hazardous waste disposal units, thereby achieving zero wastewater discharge.

Yuanda Environmental Protection strictly complies with the Law of the People's Republic of China on the Prevention and Control of Atmospheric Pollution, promoting the coordinated governance of organized emissions of atmospheric pollutants. It strengthens the management of unorganized emissions during material transportation, loading and unloading, storage, transfer processes and material preparation stages, with a focus on implementing measures related to the control of unorganized atmospheric emissions. The Company prepares and registers emergency response plans for heavily polluted weather in accordance with regulations to ensure that pollution reduction measures during special periods such as responses to heavily polluted weather and safeguards for major events are feasible.

As a domestic high-tech environmental protection enterprise engaged in flue gas pollution control, the Company possesses profound technical expertise in the field of atmospheric pollution prevention. Leveraging its dual strengths in "industry + scientific research" , the Company continuously increases investment in R&D, explores more efficient technologies and solutions for atmospheric pollution prevention, actively responds to national environmental protection policies and makes positive contributions to China's atmospheric pollution prevention efforts.
